- The quotations shall be submitted according to the terms and conditions specified in paragraph 3 to 15.Unless specified otherwise in the quotations ,it shall be construed that the terms and conditions stipulated hereunder have been agreed to.
- 3. The rates should be F.O.R and should include excise duty sales tax, freight charges any other taxes ,rates or impositions which are leviable e.g packing charges in respect of the supplies. The School /Institution shall not be liable to pay any tax ,freight etc which has not been expressly stipulated in the quotation in the event of acceptance of the quotation.
- 4. There should not be any overwriting or corrections in the quotation. If a figure is to be amended , it should be neatly scored out ,the revised figure written above and the same attested with full signature and date. In the absence of such attestation the quotation is liable to be rejected.
- 5. The undersigned does not bind himself to accept the lowest quotation and reserves the right to accept the quotation in whole or in part i.e with respect to all the articles mentioned in the attached statement or in respect of one or more than one articles specified in the attached statement as he may decide.
- 6. On acceptance of the quotation it will become a contract and the contractor shall be bound by the terms and conditions of the quotation.
- 7. The person/persons whose quotation is accepted, herein after called the contractor ,shall deposit an earnest money of Rs 10000/=(Ten thousand) along with the quotation ,which will be refunded in the event of rejection of the quotation. The earnest money will be forfeited in the event of failure to comply with the contract. In the event of acceptance of quotation ,the earnest money will be adjusted towards security deposit which shall be payable at the rate mentioned below:

- 9. The quantity of the articles indicated in the attached statement may be increased or decreased at the discretion of the undersigned without assigning any reason.
- 10. Prior to acceptance of quotation ,the undersigned reserves the right to call for samples or demonstration and the contractor shall be liable to supply the samples or give the demonstration free of cost.
- 11. In the event of acceptance of quotation and placing of the order for purchase ,the article ordered for would be subjected to an inspection by the undersigned or my representative and are liable to be rejected if the articles supplied are not according to approved samples or do not conform to the specifications prescribed.

- 14. The amount of Security Deposit shall be retained by the School /Institution for a period of six months from the date of completion of supplies as a safeguard against any defect appearing in the articles supplied within this period.
