Dear Parents

As we settle into the new academic session of the school, we begin with a great new spirit to ASPIRE for our ideals and ACT to ACHIEVE them. We envision for our children to be Lifelong Learners with a global outlook and a compassionate attitude. To promote the holistic growth of the children, various scholastic and as well as co-scholastic activities, events and competitions are conducted throughout the school calendar.

We extend our sincere thanks to our parents for their constant co-operation in all our endeavours. We had requested you to pay the tuition fee arrears for the session 2017-18 and 2018-19, as per Order of the Hon'ble High Court. The matter is now sub-judice. The final hearing is expected in May, 2019. The payment of the aforesaid arrears in respect of the students, who have made the same, will be accommodated by the school as per the order of Hon'ble High Court.

As per submission of the proposal for the fee hike to the Directorate of Education, the school has been allowed to increase the tuition fee by 10% w.e.f. 01-04-2019 vide its order dated 29.03.2019.

You have already been apprised of the details of the reclassification of some fee heads which was made from the previous academic session 2018-19 **without any increase** in total fee amount, to cover the establishment cost from the tuition fee to be in line with the guidelines of DOE. With the **10% hike in the tuition fees based on Tuition fee as on April, 2017** and the with the reclassification of fee heads, the fees payable from April, 2019 is as under

Kindly make a note of the following points with respect to the fees payment. :

- ❖ The fees, being charged as per order of Directorate of Education dated 29.03.2019, is Subject to Revision. The proposal for the fee hike for the session 2017-18 and 2018-2019 are still under consideration. The revision in the fees will be finalized after the order of Hon'ble Court.
- ❖ The Parents can view the payable fee amount in respect of their wards from the first day of every month on the school online fees payment portal on vvdav.org. The payable fee amount is also informed individually through SMS.
- ❖ For the convenience of parents, the last date for payment of fees without late fine has been extended upto 14th of every month. However, the fees for the month of April, 2019 will be accepted without late fine upto 14th May, 2019.
- ❖ Account payee cheque in favour of 'Principal Veda Vyasa DAV Public school, Vikas Puri' will be accepted for the current month / advance only till the 12th of the fee deposit month. After 12 of every month, fees will be accepted only through Demand Draft or online. If a cheque is dishonoured by the bank for any reason/due to insufficient funds, then charges @ Rs. 750/- per cheque will be levied along with the late fee fine charges as applicable upto that day. The fees from such students will not be accepted by cheque in future.
- ❖ Kindly use any of the following modes to pay the fees:
 - Online payment on School portal through Debit/Credit cards
 - Net Banking : ECS/ NACH for automatic transfer of the fees amount from your bank accounts (For availing ECS facility, you are required to fill ECS mandate forms, which are available with the class- teachers and at the school Gate No. 1)
 - Demand Draft/Cheques .
- ❖ It is requested to follow the school fees payment procedure/schedule, as mentioned in the students almanac.
- ❖ Kindly visit the school website vvdav.org regularly for circulars, news about the school events, achievements, updates
