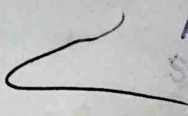

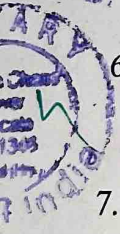

I Monica Khanna W/o Sh. Anil Khanna Principal of the DAV Public School, Ratia do hereby solemnly affirm and sincerely state as follows:



1. The DAV College Trust and Management society is a registered society under the ACT XXI of 1860.

The saving if any after meeting the recurring and non-recurring expenditure and contributions to Developmental, Depreciation and Contingency funds will be further utilized for promoting the school and extending the causes of education in the same school only.
5. That school is not paying any charges towards using name, motto, logo or any other non-academic activities to any other institution, organization or body.
6. That the school will not open classes under CBSE pattern particularly class IX/X/XI/XII and will not use CBSE name in any manner without obtaining affiliation.
7. That the Principal and Manager of the School have individually gone through the provisions contained in the affiliation & examination byelaws and the circulars issued by the Board from time to time. The school undertakes to abide by the provisions contained in affiliation & examination byelaws, directions issued from time to time and the law of the land.
8. That the school will ensure compliance of all statutory requirements like EPF,ESI and Labour Laws etc. with respect to the school and staff of the school.



9. That the school will ensure that the Building Safety, Fire Safety, Water Safety, Health and Hygiene certificates are being issued or renewed by the concerned municipal or state authorities from time to time as per the prescribed terms.
10. That the school will ensure that all required infrastructure is available with the school before starting classes.
11. That the school will ensure that sufficient number of qualified teachers as per the provisions contained in affiliation bylaws are available with the school before starting classes.
12. That the school will follow the provisions related to fee contained in affiliation bylaws and will disclose the detail of the fee to the parents/students every year before start of session without resorting to any hidden charges in the heads of the fee.
